Chennai, Oct 17: The National Stock Exchange of India (NSE) hosted the listing ceremony of the public issue of Green Municipal Bonds issued by the Surat Municipal Corporation (SMC), in the presence of the Hon'ble Chief Minister of Gujarat, Shri Bhupendra Patel.

The event was attended by several senior dignitaries and government officials, including Shri Daxesh Mavani, Mayor of Surat City; Shri Ashishkumar Chauhan, MD & CEO, NSE; Smt. Shalini Agarwal, IAS, Commissioner, Surat

South Indian Bank profit rises 8% at Rs. 351 cr

Chennai, Oct 17: South Indian Bank reported an 8 per cent rise in net profit to Rs 351 crore for the second quarter ended September 30 of the current fiscal year.

The Kerala-based private sector bank had a standalone net profit of Rs 325 crore in the September quarter of the 2024-25 fiscal year.

Interest income remained flat at Rs 1,875 crore during the September quarter of FY26, as against Rs 1,878 crore in the year-ago period.

Provisions against bad loans fell to Rs 63 crore during the quarter, down from Rs 110 crore in the July-September period of last fiscal.

Gross non-performing assets (NPA) improved to 2.93 per cent

during Q2, from 4.40 per cent of total loans in September 2024.
